

Amendment: Article VI, Amended and Restated Articles of Incorporation

## ARTICLE VI OFFICERS AND DIRECTORS:

The affairs of this Corporation shall be managed by a governing Board of-six (6) Directors who shall be members of the Association and who shall be elected at the Annual Meeting of the Corporation as provided in the Bylaws.
