It has come to my attention that the above mentioned annual report was submitted to the Secretary of State on Feb 18, 2016, copy attached. Until today, 12/06/2016, I was unaware that my electronic signature was used on this document. Its use was both without my knowledge and without my permission.

Since I am aware that this report does not reflect correct information, I would not have and did not certify it with my signature. In addition, this report does not properly reflect the number of Board Members according to our documents filed with The Secretary of State or our Corporate Bylaws. I resigned as Interim President of this organization on November 23, 2015, and properly notified both the state, through the management company, and the Homeowners' Association, (copy of my resignation and the email to all board members and management company attached), and have not had contact with anyone involved since that date.

Nothing involving this corporation should have my name attached to it after 11/23/2015. I am also not serving on the board as Past-President as recorded on this document and have not attended any meetings. I was immediately removed from their email links and have received no information related to Board activities since that time and, in fact, have no knowledge of their activities.

At this time, I do not know what other documents the association may have used my name to certify but any and all documentation with my signature or certification is falsified. Please be advised that my name should not appear on any business conducted by this corporation since November 2015.

As you can see from the bottom of this letter, I have advised all involved parties of this correspondence with you and expect they will each take any necessary action to correct. Please make any adjustments to the state report and take any necessary actions to remove my certification and signature.
