SCHEDULE OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
FOR  
BAYOU BREEZE CONDOMINIUM,  
PENSACOLA EXECUTIVE HOUSE CONDOMINIUM INC.

Article IX, Paragraph D of the Articles of Incorporation are amended to read as follows:

D. No amendment shall make any changes in the qualifications for membership nor the voting rights of members, nor any change in Article V hereof, without approval ~~in writing by all members and the written consent of all record owners of mortgages upon units with the condominium.~~ of not less than a majority of the Board of Directors and not less than a majority of the members of the Association. No amendment shall be made that is in conflict with the Condominium Act or the Declaration of Condominium.

Article VI, Paragraph A of the Articles of Incorporation is amended to read as follows:

A. The owners or their designated representative of all units in all said condominiums shall be members of the Association, and no other persons or entities shall be entitled to membership.
