THE UNDERSIGNED Officers of the HARDER HALL RESORT CLUB, LAKESIDE I CONDOMINIUM ASSOCIATION, INC., the not-for-profit Florida corporation organized and existing to operate and maintain HARDER HALL RESORT CLUB, LAKESIDE I, A CONDOMINIUM, according to the Declaration of Condominium thereof as recorded in O.R. Book 735, Page 82, et. seq., of the Public Records of Highlands County, Florida, as amended, hereby certify that the adoption of the following amendment to the Articles of Incorporation was approved by not less than two-thirds (2/3rds) of the Board of Directors and a majority of the Association membership present, in person or by proxy, at a duly convened membership meeting held November 3, 2005. ARTICLE 1 NAME

The name of the corporation shall be is HARDER HALL RESORT CLUB, LAKESIDE I CONDOMINIUM ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "Association", these Articles of Incorporation as the "Articles", and the By-Laws of the Association as the "By-Laws".

ARTICLE 2 PURPOSE
