TRINITY CHURCH OF THE NAZARENE OF LAKE CITY, INC. (the "Merged Corporations")

INTO

LAKE CITY CHURCH OF THE NAZARENE, INC. formerly known as LAKE CITY FIRST CHURCH OF THE NAZARENE, INC. (the "Surviving Corporation")

ARTICLES OF MERGER dated January 22, 2006, between LAKE CITY FIRST CHURCH OF THE NAZARENE, INC., a Florida corporation, hereinafter called "FIRST CHURCH", and TRINITY CHURCH OF THE NAZARENE OF LAKE CITY, INC., a Florida corporation, hereinafter called "TRINITY CHURCH."

Lake City First Church Of The Nazarene, Inc. is a corporation organized and existing under the laws of the State of Florida, as a not-for-profit corporation. Trinity Church is a corporation organized and existing under the laws of the State of Florida, as a not-for-profit corporation.

The Church Boards of First Church and Trinity Church, respectively, deem it desirable and in the best interests of the corporations and their members that First Church and Trinity Church be merged into LAKE CITY CHURCH OF THE NAZARENE, INC. formerly known as Lake City First Church of the Nazarene, Inc., and the corporations desire that they so merge under and pursuant to the laws of the State of Florida.

NOW, THEREFORE, IN CONSIDERATION OF THE PREMISES AND THE MUTUAL COVENANTS AND AGREEMENTS HEREIN SET FORTH, AND FOR THE PURPOSES OF PRESCRIBING THE TERMS AND CONDITIONS OF THE MERGER, THE PARTIES AGREE AS FOLLOWS:

1. As soon as the members of First Church and Trinity Church have approved this merger, Trinity Church shall be deemed to have merged with and into First Church, which shall survive the merger and which shall change its name to Lake City Church of the Nazarene, Inc. The effective date for the merger for tax and church accounting

purposes shall be January 22, 2006.

- 2. The name of the surviving corporation shall be Lake City Church of the Nazarene, Inc. The purposes for which the surviving corporation is formed and the nature of the business to be transacted by it shall be as set forth in the Articles of Incorporation of First Church.
- 3. The Church board of Lake City Church Of The Nazarene, Inc. as the surviving corporation shall consist of the present board of First Church and the present board of Trinity Church, who shall hold office until the next annual meeting of the members of the merged corporation, and until their successors have been elected and qualified. The officers will be appointed by the District Superintendent in jurisdiction and will hold office until their successors have been duly elected and qualified.
- On the effective date of the merger, all of the tangible, intangible, real and personal property, rights, privileges and franchises, of whatsoever nature and description of Trinity Church, including any pending transactions or negotiations attributed to each of them, shall be transferred to, vested in and shall devolve upon Lake City Church Of The Nazarene, Inc. as the surviving corporation, without further act or deed; and all property rights, privileges and franchises, and every other interest, shall be as effectually the property of Lake City Church Of The Nazarene, Inc. as the surviving corporation as they were of each of the respective corporations, and the title to all real estate vested in any of the corporations shall not be deemed to revert or to be in any way impaired by reason of the merger, but shall be vested in Lake City Church Of The Nazarene, Inc. as the surviving corporation. debts, liabilities and duties of the respective corporations shall, thereafter, be assumed by and attached to Lake City Church Of The Nazarene, Inc. as the surviving corporation, and may be enforced against it to the same extent as if such debts, liabilities and duties have been incurred or contracted by Lake City Church Of The Nazarene, Inc. as the surviving corporation.
- 5. Lake City Church Of The Nazarene, Inc. as the surviving corporation shall pay all expenses of the merger agreement and reserves the right to subsequently amend its Articles of Incorporation at any time hereafter, in accordance with the provisions of the laws of the State of Florida.
- 6. The Church board and membership of First Church, and Trinity Church, by a combined vote of 60 to 3, approved and adopted

these Articles and Plan of Merger at a meeting held on January 22, 2006, for such purpose on the date of execution of these Articles and Plan of Merger.

- 7. The officers of First Church and Trinity Church shall cause these Articles of Merger to be filed with the Secretary of the State of Florida in conformity with the laws of that State.
- 8. Lake City Church Of The Nazarene, Inc. as the surviving corporation will furnish a copy of these Articles and Plan of Merger to any of the members of First Church and Trinity Church upon request and without charge.

IN WITNESS WHEREOF, the President and Secretary of LAKE CITY FIRST CHURCH OF THE NAZARENE, INC., a Florida corporation, and TRINITY CHURCH OF THE NAZARENE OF LAKE CITY, INC., a Florida corporation, hereby execute these Articles as of the 22nd day of January, 2006.
