**AMENDED AND RESTATED ARTICLES OF INCORPORATION  
FOR

The undersigned hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a Florida Not-for-Profit Corporation, with no stock issued or to be issued in accordance with the laws of the State of Florida.
