## ARTICLES OF DISSOLUTION

Pursuant to the applicable Florida Statute, PALM SPRINGS PRESBYTERIAN CHURCH, INC., a Florida Non Profit Corporation, hereby submits its Articles of Dissolution and states as follows:

PALM SPRINGS PRESBYTERIAN CHURCH, INC., a Florida Non Profit Corporation, (hereinafter referred to as the "Church"), is currently filed with the Florida Department of State under Document No 763411.

In accordance with the Constitution of the Church and The Presbytery of Tropical Florida, governing the Church and authorizing the dissolution of Palm Springs Presbyterian Church, Inc., the following resolutions were adopted:

IT WAS RESOLVED, that on March 19, 2009, The Presbytery of Tropical Florida hereby directs the Administrative Commission of the Church to finalize all arrangements to close and dissolve the Church.

IT WAS FURTHER RESOLVED, on March 29, 2009, by a meeting of the Session of the Church, including a quorum of the elders, that the corporation be dissolved.
