Pursuant to Sections 617.1402 and 617.1403, Florida Statutes, CENTER FOR CHILDREN IN CRISIS, INC., a Florida not for profit corporation submits the following Articles of Dissolution:

- FIRST:** The name of the corporation is Center For Children In Crisis, Inc. (the "Corporation").
- SECOND:** The Corporation's Articles of Incorporation were filed on June 4, 1982.
- THIRD:** The Corporation has no members with voting rights.
- FOURTH:** Pursuant to Section 617.1402(2), Florida Statutes, a resolution to wind down and dissolve the Corporation was unanimously adopted by the Board of Directors of the Corporation at a meeting on September 4, 1998.
- FIFTH:** In accordance with Section 617.0123(1), Florida Statutes, the dissolution of the Corporation shall be effective upon filing of these Articles of Dissolution with the Florida Department of State.
