## To Whom It May Concern:

I, Shara Holt, the acting treasurer of Florida Council of Teachers of English just since April 2005, attempted to file the federal income tax forms this year and was informed by the accounting firm that unless we had an annual report on file with the state of Florida, we would be unable to file. Much to our chagrin, we discovered that our file had been inactive since 1998; however, our federal forms had been filed every year up to thisone.

I contacted your office and was told that I could write a letter in hopes of waiving the \$175 reinstatement fee. I am sending a check for \$551.25, which equals \$61.25 multiplied by nine (9) years. I believe that my explanation will satisfy this requirement.

Though I have no way of knowing, because the previous officers are no longer available, this is what I believe to have happened. The officers changed at the end of term in 1997, and the form was probably mailed to the previous treasurer. She or he neglected to send the form to the new treasurer, who did not have an idea that there was such a form to file. Why the accountant who filed the taxes did not realize this is an unanswered question.

Please inform me of what our next steps are to be because we must file the federal forms. I did get a three-month extension, but I am not anticipating that it will take that long to clear up this matter.
