

1. The Articles of Incorporation are hereby amended to change the name of the corporation to:

Holy Trinity Episcopal Church of Bartow, Inc.

2. All remaining provisions of the corporation's Articles of Incorporation remain in full force and effect, except for the name change set forth above.
3. The change in the name of this corporation as provided in these Articles of Amendment shall be effective upon filing with the Florida Secretary of State.
4. These Articles of Amendment do not require action or approval of the members, and the Articles were adopted May 31, 2011 by the Vestry, being this corporation's board of directors.
