Article VI, Paragraph A, of the Articles of Incorporation is amended to read as follows:

A. The affairs of the corporation will be managed by a Board consisting of the number of Directors determined by the By laws, but not less than three (3) Directors nor more than seven (7) five (5) Directors. Directors must need not be members of the corporation.

Article X of the Articles of Incorporation is amended to read as follows:

Amendments to the Articles may be proposed by any member of the Board of Directors and adopted by <u>seventy-five percent (75%)</u> of the Board of Directors and by not less than seventy-five percent (75%) of the members of the Association voting in person or by proxy at a properly noticed meeting at which a quorum is present a majority vote thereof, in the manner provided in the By Laws.
