#### ARTICLES OF AMENDMENT

#### **OF**

## SUNCHASE CONDOMINIUM ASSOCIATION OF GULF BREEZE, INC.

Article 5, Section 1 of the Articles of Incorporation of Sunchase Condominium Association of Gulf Breeze, Inc. is hereby amended to read:

- 5.1 The affairs of the Association will be managed by a board consisting of the number of directors determined by the By-Laws, but not less than three directors, and in the absence of such determination shall consist of three directors. Members of the Board of Directors must be:
  - (a) Members of the Association;
- (b) Non-members of the Association who occupy a unit within the condominium at the time of the election of Directors, and who:
  - (i) have received the approval of seventy percent (70%) of the members voting at an annual meeting at which a quorum is present, or
  - (ii) have received the approval of seventy percent (70%) of the remaining members of the Board of Directors voting at a duly constituted meeting of the Board of Directors, which seventy percent must consist of at least five (5) members of the Board of Directors, or

(iii) are representatives of a property management company or agency that is under contract with the corporation at the time of the election of Directors.
Such a representative shall serve on the Board of Directors at the pleasure of, in such capacity, and under such conditions as the Board of Directors shall determine from time to time.

The remaining portions of the Articles of Incorporation and of Article 5 of the Articles of Incorporation shall not be changed or affected by these Articles of Amendment.

These Articles of Amendment were approved by the members and the directors of the corporation in accordance with Article 9 of the Articles of Incorporation at a Special Meeting of the members and directors of the corporation called for that purpose on July 27, 1998.
