- 3. Terms and Conditions. The terms and conditions of the Merger (in addition to those set forth elsewhere in this Plan) and the mode of carrying the same into effect are as follows:
- 3.1 Upon March 31, 2022 and filing and approval of the Articles of Merger with the Florida Department of State (the "Effective Time"): i) Fund shall be merged with and into Foundation and Foundation shall be the surviving entity and shall have all the rights, privileges, immunities, and powers and shall be subject to all the duties and liabilities of a corporation under the Florida Statutes; ii) the separate existence of Fund shall cease; iii) Foundation shall thereupon and thereafter possess all the rights and privileges, immunities, and franchises, of a public as well as of a private nature, of Fund; and all property, real, person, and mixed, and all debts due on whatever account, including all choses in action, and all and every other interest, of or belonging to or due to Fund shall be taken and deemed to be transferred to and vested in Foundation without further act or deed; and iv) all corporate acts, plans, policies, contracts, approvals and authorizations of Fund and its respective partners, officers and agents, that were valid and effective immediately prior to the Effective Time, shall be taken for all purposes as of the acts, plans, policies, contracts, approvals and authorizations of Foundation and shall be as effective and binding thereon as the same were with respect to Fund.

If at any time after the Effective Time Foundation shall consider or be advised that any further deeds, assignments or assurances in law or in any other things necessary, desirable or proper to vest, perfect or confirm, of record or otherwise, in Foundation, the title to any property or rights of Fund acquired or to be acquired by reason of, or as a result of, the Merger, Fund (or the proper officers and trustees of such) shall execute and deliver such proper deeds, assignments and assurances in law and do all things necessary, desirable or proper to vest, perfect or confirm title to such property or rights in the Surviving Entity and otherwise to carry out the purpose of this Plan.

- 4. The Articles of Incorporation of Foundation. The Articles of Incorporation of Foundation shall be amended and restated as of the Effective Time upon filing with the Secretary of State.
- 5. Miscellaneous.
- 5.1 Capitalized terms used and defined in this Plan shall have the meanings assigned to such terms.
- 5.2 For the convenience of the parties, any number of counterparts hereof may be executed and each such counterpart shall be deemed to be an original instrument.
- 5.3 This Plan shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
