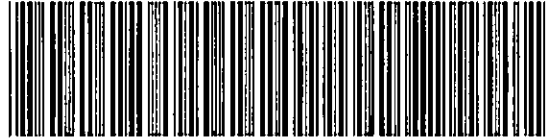



AMENDMENT TO ARTICLES OF INCORPORATION FOR  
COTE DE LA MER RESIDENTIAL ASSOCIATION

I. AMENDED ARTICLES OF INCORPORATION

1. Article IX of the Articles of Incorporation shall be amended to read as follows:

~~The number of members of the first Board of Directors shall be four (4). The Board may be increased to any number not to exceed eight (8). The number of Board of Directors shall be up to seven (7) persons. The Directors will be elected each year at the annual meeting of the Association as provided for in the By-Laws. Only a member of the Association can be elected to the Board of Directors. However, a person who is delinquent in the payment of any fee, fine or other monetary obligation to the association on the day that he or she could last nominate himself or herself or be nominated for the board may not seek election to the board.~~
