EXHIBIT "A" AMENDMENTS TO THE ARTICLES OF INCORPORATION OF ST. ANDREWS COUNTRY CLUB, INC.

Article XIV, GOLF AND TENNIS MEMBERS, is hereby modified as follows:

The maximum number of members of any category of membership in the Club shall be established in the Bylaws as same may be amended from time to time. The Club shall have a maximum of six hundred thirteen (613) golf members and seventy five (75) tennis members and one (1) charter member, as described in ARTICLE XV hereof. Notwithstanding any term hereof to the contrary, any reference to tennis members in these Articles shall refer to the rights and privileges of tennis members from time to time, but shall not be construed to require the establishment of tennis memberships other than as may be required or provided for under the Bylaws of the Club.

The balance of Article XIV remains unmodified.
