EXHIBIT "A"

AMENDMENTS TO THE ARTICLES OF INCORPORATION OF ST. ANDREWS COUNTRY CLUB, INC.

The Club shall have no more than fifteen (15) members on its Board of Governors. A spouse of a Member of the Club shall be permitted to stand for election to the Board of Governors and serve on the Board of Governors notwithstanding the fact that such spouse may or may not own title to a lot in the St. Andrews Country Club Planned Unit Development, and solely for the purpose hereof, such spouse shall be considered a "Qualified Person" under ARTICLE XIII of the By-Laws able to stand for election to the Board of Governors. Election of persons to serve on the Board of Governors shall be further subject to the provisions of Article XIII of the By-Laws. The number of members of the Board of Governors will be determined by the By-Laws.
