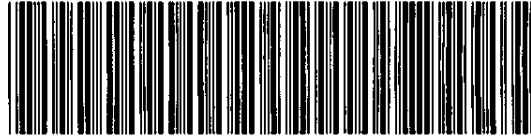

**CERTIFICATE OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF**

SOUTH RIVER VILLAGE TWO CONDOMINIUM ASSOCIATION, INC.

The Articles of Incorporation of South River Village Two Condominium Association, Inc. were filed with the Florida Secretary of State on October 14, 1982. The same Articles of Incorporation were recorded in Official Records of Martin County, Florida at Official Records Book 554, Page 2493, et. seq., and amended at OR Book 800, Page 1543, et. seq. and OR Book 2507, Page 2767. The same Articles of Incorporation are hereby amended as adopted by written consent of a majority of the membership.

1. Article V, Section 5.1 is amended to read as follows:

**ARTICLE V
DIRECTORS**

5.1 Number and Qualification. The affairs of the Association shall be managed by a board consisting of five (5) directors. Each director shall have a recorded ownership interest in a Unit within South River Village Two Condominium.

(The balance of Article V remains unchanged)

2. The foregoing amendment to the Articles of Incorporation of South River Village Two Condominium Association, Inc. was adopted by the majority of the membership by written consent.
3. All provisions of the Articles of Incorporation of South River Village Two Condominium Association, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
