The following amendments to the ARTICLES OF INCORPORATION Of the Whispering Pines, Lakeview, and Catalina Village Neighborhood Association, Inc. March 16, 2009

ARTICLE 1: NAME: The name of this corporation shall be the Whispering Pines, Lakeview, and Catalina Village (WLC) Neighborhood Association, Inc.

ARTICLE 3. MEMBERS: (a) The members of the corporation shall be residents of the Whispering Pines, Lakeview, and Catalina Village subdivisions. (b) Members of this corporation shall be admitted by paying dues of \$25.00 per year per household effective January or February 2010.

ARTICLE 6. OFFICERS: the affairs of this corporation shall be managed by officers elected by the membership. The officers shall serve for a term consisting of two (2) years. Elections will be held every two years beginning March 2007. The current officers are: President, Vice President, Secretary, Assistant Secretary, Treasurer, and Assistant Treasurer. (Note: The offices of Chaplain, Assistant Chaplain, and Sergeant at Arms are voluntary or by appointment.)

ARTICLE 7. (b) The term of office shall be for two (2) years.
