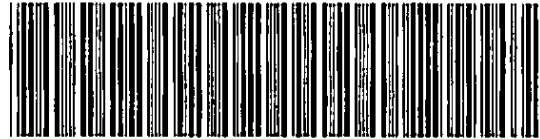

AMENDMENT TO THE ARTICLES OF INCORPORATION
OF THE VILLAGE OF CEDARBEND HOMEOWNERS ASSOCIATION, INC.

DOCUMENT NO. 765822

Article III, Section (d), of the Articles of Incorporation is deleted in its entirety and replaced with the following:

(d) borrow money, provided, however, the Board must obtain the approval of not less than a majority of all of the members to (1) mortgage, pledge, deed in trust or hypothecate any or all of the its real property as security for money borrowed or debts incurred; or (2) borrower more than \$500,000.00 in any annual budget period.
