1. The name of the corporation is **TRINITY CHURCH, REFORMED EPISCOPAL, INC.** (the "Corporation").
2. The Corporation was formed in the State of Florida effective January 17, 1983, under Document No. 766575.
3. The Corporation has no members or members with voting rights.
4. The Board of Directors authorized the dissolution of the Corporation pursuant to an Action of the Board of Directors by Unanimous Written Consent in Lieu of Special Meeting dated Feb. 24, 2006. The number of Directors in office was two (2) and the vote was unanimous in favor of dissolution of the Corporation.
5. Dissolution of the Corporation shall be effective on the date these Articles of Dissolution are filed by the Secretary of State.
