Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment to its Articles of Incorporation:

FIRST: Article 1 of the Articles of Incorporation shall be deleted in its entirety and the following text was adopted by the Corporation as the new Article 1 to its Articles of Incorporation:

ARTICLE 1 - NAME

The name of this Corporation is GUARDIAN AD LITEM FOUNDATION - 20TH JUDICIAL CIRCUIT, INC.
