The Amended and Restated Articles of Incorporation were recorded in the St. Lucie County Public Records on September, 25, 2006 at OR Book 2663, Page 2387.

The following provisions of Article I, Sec. 1 of the Amended and Restated Articles of Incorporation of Panther Woods Master Association, Inc., are hereby Amended as follows:

1. The name of the corporation is hereby changed to Meadowood Community Association, Inc.
2. The date of adoption by the Board of Directors of a resolution approving the change of name of the corporation to Meadowood Community Association, Inc., is March 3, 2010.
