The undersigned officers of GULL AIRE VILLAGE ASSOCIATION. INC., a Florida corporation not-for-profit, do hereby make, subscribed, acknowledge and file with the Secretary of State these Articles of Amendment in accordance with the unanimous vote of the Board of Directors and the unanimous approval of all voting rights of the Association as follows:

Article IV of the Articles of Incorporation of Gull Aire Village Association, Inc., is amonded to read as follows:

"The purpose of this corporation is to act as the governing association for the maintenance of certain properties located in the City of Oldsmar, Pinellas County, Plorida, and commonly known as Gull Aire Village, or as the same may be known in the future, in accordance with the "Asended Covenents and Restrictions of Gull Aire Village," recorded in the office of the Clerk of Pinellas County, in O.R. Book 5233, Page 773 through Page 780, so the same may be smended from time to time.
