

#### AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

### FLORIDA STATE ASSOCIATION OF PARLIAMENTARIANS, INC. Doc # 766927



#### **ARTICLE I**

#### **CORPORATE NAME**

The name of this corporation shall be FLORIDA STATE ASSOCIATION OF PARLIAMENTARIANS, INC.

#### **ARTICLE II**

#### **CORPORATE PURPOSE**

This association is organized exclusively for the educational purposes of studying, teaching, promoting and disseminating the philosophy and principles underlying the rules of deliberative assemblies, and carrying out such other activities as may be necessary or useful in the furtherance of these purposes in accordance with Section 501(c)(3) of the Internal Revenue Code, or a corresponding section of any future tax code, and to promote the object and educational programs of NATIONAL ASSOCIATION OF PARLIAMENTARIANS (NAP), and to be the NAP association for Florida.

#### **ARTICLE III**

#### PRINCIPAL PLACE OF BUSINESS ADDRESS AND MAILING ADDRESS

The principal place of business and mailing address of the corporation shall be located in the State of Florida as approved from time to time by the board of directors. The current principal place of business and mailing address of the corporation is located at 6703 121st Ave E. Parrish, FL 34219.

#### **ARTICLE IV**

#### OFFICERS AND DIRECTORS

The directors shall include the officers elected by the members consisting of at least a president, vice-president, and recording secretary in addition to other officers and directors, as specified in the bylaws. The affairs of the corporation shall be managed by the board of directors subject to the approval of the members of the corporation, as provided in the bylaws.

#### **ARTICLE V**

#### **AMENDMENT**

These Articles of Incorporation may be amended by a majority vote at a membership meeting.

#### **ARTICLE VI**

#### DISSOLUTION

Upon the dissolution of the corporation, the board of directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code, or a corresponding section of any future tax code, as the board of directors shall determine. Any such assets not so disposed of shall be disposed of by the court of competent jurisdiction in the county in which the principal office of the corporation is located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.

#### CERTIFICATE
