**ARTICLES OF AMENDMENT OF
BAPTIST HEALTH AFFILIATES, INC.**

STATE OF FLORIDA
COUNTY OF ESCAMBIA

We, the Chairman and the Assistant Secretary of Baptist Health Affiliates, Inc., a not for profit corporation organized under the laws of the State of Florida (the "Corporation"), do hereby make and attest these Articles of Amendment, and certify as follows:

(1) The name of the Corporation is Baptist Health Affiliates, Inc.

(2) The following amendments have been adopted in accordance with the requirements set forth in Chapter 617 of the Florida Statutes:

(A) Article I of the Articles of Incorporation of the Corporation is deleted in its entirety, and replaced with the following new Article I:

ARTICLE I

The name of the corporation shall be JAY HOSPITAL, INC. The principal office of the corporation shall be located at 1000 West Moreno Street, Pensacola, Florida, or at such other place as may from time to time be designated by the Board of Directors.

(3) The foregoing amendment was adopted by a vote of the Corporation's sole member, Baptist Health Care Corporation, on February 5, 2001, which vote was sufficient for the amendment's approval.

IN WITNESS WHEREOF, we have made and executed these Articles of Amendment, this 16 day of January, 2001, at Pensacola, Florida.

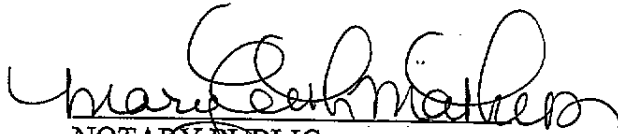

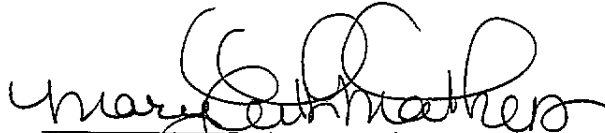
