



Pursuant to the provisions of Section 607.1006, Florida Statutes, this *Florida Not for Profit Corporation* adopts the following amendment to its Articles of Incorporation:

The Amendment to the existing Articles of Incorporation being affected hereby is that resulting from completely deleting Article VII of the Article of Incorporation as of the date hereof, and substituting in its place and stead the Article VII set forth below:

### ARTICLE VII

### Officers and Trustees

The affairs of this corporation shall be managed by a Board of Trustees who shall be elected by the Board of Trustees of this corporation as provided in the by-laws and by officers who shall be elected by the Board of Trustees. The officers to be elected shall be a president, a vice president, a secretary and a treasurer and such other officers as may be provided for in the by-laws of this corporation. The duties of the respective officers and the manner of filling vacancies in the offices of this corporation shall be provided in the by-laws.

The number of Trustees and the manner of filling vacancies in the Board of Trustees shall be provided in the by-laws of this corporation. The number shall not be less than two (2) nor more than five (5). A quorum for the transaction of business shall be a majority of the Trustees qualified and active, and the act of a majority of the Trustees present at a meeting at which a quorum is present shall be the act of the Trustees. Meetings of the Trustees may be held within or without the State of Florida. Trustees and Officers shall be members of this corporation, if members are admitted to this corporation.
