ARTICLES OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF ST. MARY'S FOUNDATION OF PALM BEACH COUNTY, INC

Pursuant to the provisions of section 617.1006 of the Florida Statutes, St. Mary's Foundation of Palm Beach County, Inc., a Florida not-for-profit corporation, adopts the following Articles of Amendment (the "Amendment") to amend its Amended and Restated Articles of Incorporation (the "Articles of Incorporation"):

1. The Articles of Incorporation of St. Mary's Foundation of Palm Beach County. Inc., a Florida not-for-profit corporation (the "Corporation") are hereby amended for the purpose of changing the name of the Corporation.

2. The text of the amendment adopted by the Corporation is as follows:

ARTICLE I NAME

The name of the Corporation is Allegany Franciscan Foundation, Palm Beach County, Inc.

3. All other references to the name "St. Mary's Foundation of Palm Beach County, Inc." as contained in the Articles of Incorporation shall be changed to read "Allegany Franciscan Foundation, Palm Beach County, Inc."

4. The foregoing amendment was duly adopted by the Members of the Corporation at a meeting of the Members on June 8, 2001, and by the Trustees of the Corporation at a meeting held on June 8, 2001. The number of votes cast for the amendment was sufficient for approval.
