Such disclosure shall include any relevant material facts known to such person about the contract or transaction that might reasonably be construed to be averse to the corporation's interest.

The body to which such disclosure is made shall thereupon determine, by a vote of seventy-five (75%) of the votes entitled to vote, whether the disclosure shows that a conflict of interest exists or can reasonably be construed to exist. If a conflict is deemed to exist, such person shall not vote on, nor use his personal influence on, nor participate (other than to present information or to respond to questions) in, the discussions or deliberations with respect to such contract or transaction. Such a person may be counted on determining whether a quorum is present but may not be counted when the Board of Directors or a committee of the Board acts on the transaction.
