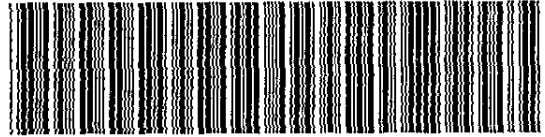

ARTICLES OF AMENDMENT

**ARTICLES OF INCORPORATION OF

The Board of Directors of LAMBS FOR CHRIST, INC., acting pursuant to ARTICLE 10 of the Articles of Incorporation, and the Florida Statutes, hereby adopts the following amendments to the Articles of Incorporation of LAMBS FOR CHRIST, INC.

1. Article I of the Articles of Incorporation is revoked and new Article I shall read as follows:

The name of the corporation is changed to THE RIGHT PATH, INC.

2. Article III of the Articles of Incorporation is revoked and new Article III shall read as follows:

This corporation may engage in any activity permitted under the laws of the United States and the State of Florida within the following purposes:

a) To solicit and receive grants and contributions and manage the amounts received by writing, publishing, distributing religious study and addiction recovery materials, by seminars and workshops, and by providing counseling and life recovery services.

b) To transact any and all lawful business for the benefit of THE RIGHT PATH, INC.

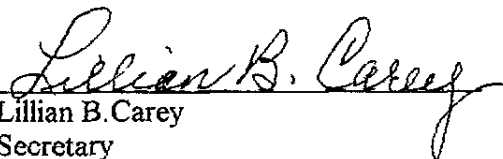
c) The purpose for which The Right Path, Inc. is organized are exclusively religious, charitable, literary and educational within the meaning of section 501(c)(3) of the Internal revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The powers of The Right Path, Inc. are limited to those within the scope of section 501 (c)(3) of the internal revenue code of 1986 of the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, The Right Path, Inc., shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. This corporation is organized exclusively for religious, charitable, educational and philanthropic exempt purposes.

Lambs For Christ, Inc.

The undersigned secretary of Lambs for Christ, Inc., in accordance with the Florida statutes, hereby certify that the forgoing Articles of Amendment were adopted by the Board of Directors of the corporation at a meeting on December 13, 2002 duly called for such purpose after having obtained approval of two-thirds of the members of the corporation for such amendment.
