ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF NORTH SHORE MEDICAL CENTER FOUNDATION, INC.

- 1. The name of the corporation is North Shore Medical Center Foundation, Inc.
- 2. The following provisions of the Amended Articles of Incorporation of the corporation, dated as of March 28, 1991, are hereby amended to read in their entirety as follows:

SECTION 3.1.2 OF ARTICLE 3

"3.1.2 To solicit, and to raise funds and endowments, and to receive by way of gift, purchase, grant, devise, will or otherwise, property, real, personal or mixed, and to hold, use, maintain, lease, donate, pledge, encumber, loan, sell, convey and otherwise dispose of all such property, for the benefit of North Dade Medical Foundation, Inc., formerly known as North Shore Medical Center, Inc., and such other not-for-profit §501(c)(3) organizations as may from time to time be controlled, directly or indirectly, by North Dade Medical Foundation, Inc."

"ARTICLE 6 MEMBERSHIP

The Corporation shall have a sole member, which shall be North Dade Med Foundation, Inc. (the "Sole Member")."

"ARTICLE 10 DISSOLUTION

Upon the dissolution of the Corporation, the Board shall, after paying or making provision for the payment of all liabilities of the Corporation, dispose of all other assets of the Corporation to North Dade Medical Foundation, Inc. if still in existence and qualifying as an exempt organization under Section 501(c)(3) of the Code or, if not in existence and tax exempt, to such organization or organizations organized and operated exclusively for charitable, educational, or scientific purposes as shall at the time qualify as exempt organization(s) under Section 501(c)(3) of the Code, as the Board shall determine to be best calculated to carry out the objects and purposes for which the corporation has been formed. Any such assets not so disposed of shall be disposed of by the appropriate Court of the jurisdiction in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine which are organized and operated for such purposes."
