### ARTICLE 3 POWERS

The powers of the Association shall include and shall be governed by the following provisions:

2. **ENUMERATION.** The Association shall have all of the powers and duties set forth in the Condominium Act, as well as those set forth in the Declaration of Condominium and the by-laws, and as they may be amended from time to time, including but not limited to:

g. To make and amend reasonable changes regulations respecting the modification use and appearance of the property in of the condominium; provided, however, that all alterations those regulations and their amendments shall be approved by not less than seventy-five percent (75%) of the votes of the units of the Association before they shall become effective.

### ARTICLE 5 DIRECTORS

1. Number and qualification – The affairs of the Association shall be managed by a Board consisting of the number of Directors determined by the Bylaws, but not less than three directors, and. In the absence of that determination, the number of Directors to be elected shall be the same as the previous election consist of three directors. Directors shall need not be members of the Association. A unit shall have only one (1) Representative on the Board during any term.
