CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF EMERALD LAKES TOWNHOMES HOMEOWNERS ASSOCIATION, INC.

The Articles of Incorporation of Emerald Lakes Townhomes Homeowners Association, Inc. were filed with the Florida Secretary of State on June 14, 1983. The same Articles of Incorporation were recorded in Official Records of Martin County, Florida at Official Records Book 577, Page 2618, et. seq. The same Articles of Incorporation are hereby amended as adopted by seventy-five percent (75%) of members at the Membership Meeting held February 11, 2014 and by seventy-five percent (75%) of the Board Members at the Board of Directors Meeting held February 11, 2014, which vote was sufficient for approval.

Article III is amended to read as follows:

ARTICLE III POWERS

7. To make and amend reasonable regulations regarding the use of the property of the Association, provided, however, that all such regulations and their amendments shall be approved by not less than fifty-one percent (51%) of the votes of the entire membership of the Association before such shall become effective.

(The balance of Article III remains unchanged)

- 2. The foregoing amendment to the Articles of Incorporation of Emerald Lakes Townhomes Homeowners Association, Inc. was adopted by seventy-five percent (75%) of members at the Membership Meeting held February 11, 2014 and by seventy-five percent (75%) of the Board Members at the Board of Directors Meeting held February 11, 2014, which vote was sufficient for approval.
- 3. All provisions of the Articles of Incorporation of Emerald Lakes Townhomes Homeowners Association, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
