AMENDMENTS TO ARTICLES OF INCORPORATION

- 1. <u>ARTICLE III</u>, <u>POWERS</u>, Section 2 <u>Necessary Powers</u>, Subsection G of the Articles is hereby amended as follows:
 - G. To enforce by legal means the provisions of the Declaration, these Articles,
 - > the Bylaws and the Rules and Regulations for the use of the Property, including
 - > without limitation the power to verify that a grantee of a Parcel shall have
 - > satisfied all prerequisites to become a member of the Country Club, as provided in
 - > Paragraph 10.1.1.3 of the Declaration.
- 2. ARTICLE IV, MEMBERSHIP, of the Articles is hereby amended in its entirety as follows:

Qualification for, and admission to, membership in the Association shall

- > be regulated by the Declaration and the Bylaws of the Association. Without
- > limiting the foregoing, for all Owners taking title to Parcels after the date of
- > recordation of these amendments in the Public Records, membership in the
- > Association shall be conditioned upon satisfying all prerequisites to become a
- > member of the Country Club and Association Verification thereof as provided for
- > in Section 3.2 of the Declaration.
