Greater than two thirds (%) of all the Members at said meeting, voted affirmatively to adopt the Amendment attached hereto and incorporated herein as Exhibit "A".

**THIRD:** The number of votes cast for the Amendment was sufficient for approval thereof.

### **EXHIBIT "A"**

#### **AMENDMENTS TO ARTICLES**

ARTICLE V, BOARD OF DIRECTORS, of the Articles is hereby amended as follows:

- The affairs of the Association shall be managed by a Board of Directors consisting

  of not less than three (3) seven (7) nor more than nine (9) directors. Until such time as Developer relinquishes control of the Association, as described in the Declaration, Developer shall have the right to appoint all members of the Board of Directors and to approve the appointment of all officers of the Association and no action of the membership of the Association shall be effective unless and until, approved by the Developer. Further, until turnover of control by Developer, as aforesaid, no director or officer need be a Member of the Association; thereafter,
- > however, all All directors and officers must be Members of the Association.

[The balance of this Article V, respecting rights of the Developer and the initial Board of Directors, is deleted in its entirety.]
