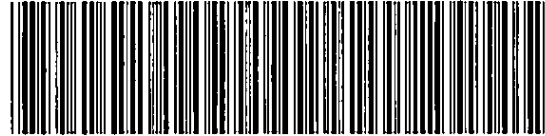

ARTICLES OF INCORPORATION OF
ST. THOMAS SQUARE
MASTER OWNERS ASSOCIATION, INC.
(A corporation not for profit)

ARTICLE I - NAME

The name of this corporation shall be ST. THOMAS SQUARE
MASTER OWNERS ASSOCIATION, INC. (the "Association").

ARTICLE II - CORPORATE EXISTENCE

The Association shall have perpetual existence.

ARTICLE III - PURPOSE

The general nature, objects and purposes of the
Association are:

- (1) To promote the health, safety and social welfare of
the owners of property within that area described in
Article IV hereof, which area will be hereinafter
referred to as the "Property."
- (2) To maintain and/or repair landscaping in the general
and/or common areas, parks, sidewalks and/or access
paths, streets, and other common areas, structures,
and other improvements for the benefit of owners of
the Property for which the obligation to maintain
and repair has been delegated and accepted.
- (3) To control the specifications, architecture, design,
appearance, elevation and location of (and
landscaping around) all buildings of any type,
including walls, fences, swimming pools, docks,
bulkheading, antennae, sewers, drains, disposal
systems, and/or other structures constructed, placed
or permitted to remain in the Property, as well as
the alteration, improvement, addition or change
thereto.
- (4) To maintain the waterways, lakes and ponds within
the Property and/or serving the Property for which
the obligation to maintain has been delegated and
accepted.

- (5) To provide for administrative, legal, accounting and financial services, and such other services the responsibility for which has been accepted by the Association.
- (6) To purchase, acquire, replace, improve, maintain and/or repair such buildings, structures, landscaping, paving and equipment, both real and personal, related to the health, safety, and social welfare of the members of the Association, as the Board of Directors in its discretion determines necessary, appropriate, and/or convenient.
- (7) To provide the services and functions authorized or required under the provisions of the Declaration, as such term is hereinafter defined.
- (8) To operate without profit for the sole and exclusive benefit of its Members.

ARTICLE IV - INITIAL PRINCIPAL OFFICE
AND REGISTERED AGENT

The street address of the initial registered office of the corporation in the State of Florida is 8600 Thomas Drive, Panama City Beach, Florida 32407, and the name of the initial registered agent at such address is R. T. Brinkley, II.

ARTICLE V - GENERAL POWERS

The general powers that the Association shall have are as follows:

- (1) To hold funds solely and exclusively for the benefit of the Members for purposes set forth in these Articles of Incorporation.
- (2) To promulgate and enforce rules, regulations, bylaws, covenants, restrictions and agreements to effectuate the purposes for which the Association is organized.
- (3) To delegate power or powers where such is deemed in the interest of the Association.
- (4) To purchase, lease, hold, sell, mortgage or otherwise acquire or dispose of, real or personal

property; to enter into, make, perform or carry out contracts of every kind with any person, firm, corporation or association; to do any and all acts necessary or expedient for carrying on any and all of the activities and pursuing any and all of the objects and purposes set forth in the Articles of Incorporation and not forbidden by the laws of the State of Florida.

- (5) To fix assessments to be levied against the Property to defray expenses and costs of effectuating the objects and purposes of the Association and to create reasonable reserves for such expenditures, and to authorize its Board of Directors to enter into agreements with condominium associations or other property owners' associations for the collection of such assessments.
- (6) To charge recipients for services rendered by the Association and the user for use of Association property where such is deemed appropriate by the Board of Directors of the Association.
- (7) To pay taxes and other charges, if any, on or against property owned or accepted by the Association.
- (8) To borrow money and, and from time to time, to make, accept, endorse, execute and issue debentures, promissory notes or other obligations of the Association for monies borrowed or in payment for property acquired or for any of the other purposes of the Association and to secure the payment of such obligation by mortgage, pledge, or other instrument of trust, or by lien upon, assignment of or agreement in regard to all or any part of the property rights or privileges of the Association wherever situated.
- (9) In general, to have all powers conferred upon a corporation by the laws of the State of Florida,

except as prohibited herein.

ARTICLE VI - MEMBERSHIP

The Members shall consist of the Developer, its successors and assigns and Owners of the Property as such terms are defined in the Declaration of Covenants, Conditions and Restrictions recorded in the Public Records of Bay County, Florida, ("Declaration"). All terms as used herein shall have the same meaning as defined in the Declaration. There shall be three classes of Members as follows:

- (1) Class "A" Members. Class "A" Members shall be all owners of Residential Dwelling Units within the Property, including the Declarant. Owners of Residential Dwelling Units shall automatically become Class "A" Members upon the purchase of such Residential Dwelling Units.
- (2) Class "B" Members. Class "B" Members shall be all Owners, including the Declarant, of Commercial Units within the Property. Owners of Commercial Units shall automatically become Class "B" Members upon the purchase of such Commercial Units.
- (3) Class "C" Members. Class "C" Members shall be the Developer or its designee, successor or assignee, as Declarant and developer of St. Thomas Square.

ARTICLE VII - VOTING AND ASSESSMENTS

- (1) Class "A" Members shall be entitled to one (1) vote for each Residential Dwelling Unit which such Member owns.
- (2) Class "B" Members shall be entitled to one (1) vote for each 1000 square feet (or fraction thereof) of heated and air conditioned space constituting the Public or Commercial Unit(s) owned by such Member.
- (3) The Class "C" Member shall be the Declarant who shall be vested with the sole voting rights in the Association until the Class "C" Membership shall cease and shall be converted to Class "A" or "B"

pursuant to Article III, Section 2(c) of the Declaration.

- (4) When any Property entitling an Owner to membership as a Class "A" or Class "B" Member is owned of record in the name of two (2) or more persons or entities, whether fiduciaries or in any other manner of joint or common ownership, one and only one of such persons who shall be designated by such owners shall become the Member entitled to vote. Such vote shall be exercised as they among themselves determine or as the covenants and restrictions applicable to such Property shall determine, but in no event shall more than one (1) vote be cast with respect to any such Property. In case the conflict among the owners has not been resolved at the time of the voting, the vote for such property shall not be counted as to the matter under consideration in which the conflict arose, whether the conflict appears by vote in person or by proxy. Where a partnership, corporation or other entity is a Class "A" or Class "B" Member, such corporation or partnership or other entity shall designate one representative of such partnership, corporation or entity to be the Member entitled to vote.
- (5) The Association shall obtain funds with which to operate by assessment of its Members in accordance with the provisions of the Declaration.

ARTICLE VIII - BOARD OF DIRECTORS

- (1) The affairs of the Association shall be managed by a Board of Directors consisting of any odd number of members, but not less than three (3) members as determined by the Board of Directors from time to time. The Board of Directors shall initially consist of three (3) Directors. The Class "C" Member shall have the right to appoint a majority of

the Board of Directors and the Class "A" and "B" shall be entitled to elect the remaining members of the Board until termination of the Class "C" membership. Thereafter, so long as the Declarant is a Class "A" or Class "B" Member, it will be entitled to appoint one (1) Director who need not be a member of the Association and the remaining Directors shall be elected as hereinafter provided.

- (2) At such time as the Class "C" Member shall no longer have the right to appoint a majority of the Board of Directors, Class "A" and Class "B" Members shall elect Board members separately for the Directors to which their respective Class voting rights entitle them. The percentage of Board members representing each class shall be based on a fraction, the numerator of which is the total amount of annual assessments against the Property owned by the Members of such class for the then current year and the denominator of which is the total amount of annual assessments against all Property owned by Class "A" and Class "B" Members. Fractions shall be rounded to the nearest whole number but should amount to at least one Board Member. At such time as Class "A" and Class "B" Members elect Directors in separate elections, there shall be a separate Nominating Committee for each class.

- (3) The names and addresses of the members of the first Board of Directors who shall hold office until their successors are elected or appointed and have been qualified, are as follows:

ARTICLE IX - OFFICERS

- (1) The officers of the Association shall be a President, a Vice President, a Secretary and a Treasurer, and such other officers as the Board may from time to time by resolution create. Any two or more offices may be held by the same person except the offices of President and Secretary. Officers shall be elected for one (1) year terms in accordance with the procedure set forth in the Bylaws.
- (2) The names of the officers who are to manage the affairs of the Association until the first annual meeting of the Board of Directors and until their successors are duly elected and qualified are:

President--Samuel G. Estok
Vice President--R. T. Brinkley, II
Secretary--Patricia Ann Estok
Treasurer--R. T. Brinkley, II

ARTICLE X - BY-LAWS

The Board of Directors shall adopt By-Laws consistent with these Articles of Incorporation. Such By-Laws may be amended by the Declarant on its own motion from the date hereof until Class "C" Membership is terminated by such amendment pursuant to Article III of the Declaration, so long as the voting power of existing members is not diluted by such amendment, nor the amounts of assessments of such existing members change in a manner which would adversely affect such members, except as provided for in the Declaration, these Articles or the By-Laws. Thereafter, the By-Laws may be amended with the approval of 51% of the votes cast at a duly called meeting of the Association.

ARTICLE XI - AMENDMENT TO ARTICLES OF INCORPORATION

These Articles may be altered, amended or repealed by the Declarant on its own motion from the date hereof until Class "C" Membership is terminated pursuant to Article III of the Declaration, so long as the voting power of existing members is not diluted by such amendment, nor the amounts of assessments of such existing members changed in a manner which would adversely affect such members except as expressly provided for in the

Declaration, these Articles or the Bylaws. Thereafter, any proposed amendment shall be deemed approved if 51% of the votes cast at a duly called meeting of the Association shall vote in favor of such proposed amendment. No amendment affecting the Declarant shall be effective at any time without the prior written consent of the Declarant.

ARTICLE XII - SUBSCRIBERS

ARTICLE XIII - DISSOLUTION OF THE ASSOCIATION

- (1) Upon dissolution of the Association, all of its assets remaining after provision for creditors and payment of all cost and expenses of such dissolution shall be distributed in the following manner:
 - (a) Real property contributed to the Association without the receipt of other than nominal consideration by or on behalf of the Declarant and/or Class "C" Member (or its predecessor in interest) shall be returned to the Declarant (whether or not the Declarant or Class "C" Member is a member at the time of such dissolution), unless it refuses to accept the conveyance.
 - (b) Property shall be dedicated to any applicable municipal or other governmental authority provided it is determined by the Board of Directors of the Association to be appropriate for such dedication and the authority is willing to accept it.
 - (c) Remaining assets shall be distributed among the Members, subject to the limitation set forth below, each Member's share of the assets to be determined by multiplying such remaining assets

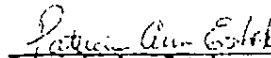
by a fraction the numerator of which is all amounts assessed by the Association since its organization against the Property which is owned by the Member at that time, and the denominator of which is the total amount (excluding penalties and interest) assessed by the Association against all properties which at the time of dissolution are part of the Property. The year of dissolution shall count as a whole year for purposes of the preceding fractions.

- (2) The Association may be dissolved upon a resolution to that effect being approved by two-thirds (2/3) of the members of the Board of Directors. After such resolution the President will nominate any of the officers of the Association to assist him in effectuating all the steps required by law to obtain a decree of dissolution and record same with the Department of State of the State of Florida.

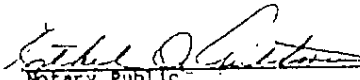

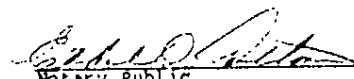
