**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF
SUNCOAST GOLF CLASSIC, INC.**

Pursuant to the provisions of Section 617.1006, Florida Statutes, SUNCOAST GOLF CLASSIC, INC., a Florida Not for Profit Corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article I of the Corporation's Articles of Incorporation is amended in its entirety as follows:

**ARTICLE I
NAME AND ADDRESS**

The name of the Corporation is **COPPERHEAD CHARITIES, INC.** The principal office (and mailing address) is located at **36750 US 19 N. PALM HARBOR FL 34684.** The Board of Directors may from time to time move the principal office of the Corporation to any other address in the State of Florida.

SECOND: Article V of the Corporation's Articles of Incorporation is amended in its entirety as follows:

**ARTICLE V
MEMBERSHIP**

The Corporation shall have members. Membership qualification, the manner of admission to membership, the classes of membership, and the rights and obligations of the members shall be as stated in the Bylaws of the Corporation.

THIRD: Article VII of the Corporation's Articles of Incorporation is amended in its entirety as follows:

**ARTICLE VII
OFFICERS**

The number and manner of election or appointment of Officers of the Corporation and their terms of office shall be as provided in the Bylaws of the Corporation. The responsibilities and duties of Officers of the Corporation shall be as provided in the Bylaws of the Corporation.

FOURTH: Article VIII of the Corporation's Articles of Incorporation is amended in its entirety as follows:

ARTICLE VIII
BOARD OF DIRECTORS

The affairs of the Corporation shall be managed by a Board of Directors. The number and manner of election or appointment of Directors and their terms of office shall be as provided in the Bylaws of the Corporation.

FIFTH: The above amendments were approved by vote of the Board of Directors of the Corporation, which vote was sufficient for approval. There are currently no members entitled to vote on these Articles of Amendment and the Articles of Amendment were adopted by the Board of Directors effective as of the date hereof.
