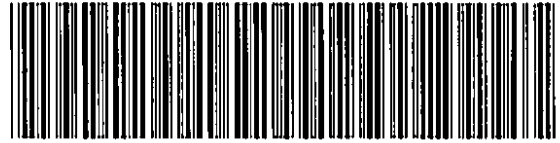

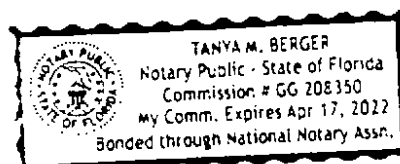

**ADOPTED AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF
INCORPORATION OF POINTE WEST RECREATION FACILITY, INC.**

Adopted amendment to ARTICLE I of the Amended and Restated Articles of Incorporation of Pointe West Recreation Facility, Inc., to read as follows:

ARTICLE I
NAME

The name of this corporation shall be ~~POINTE WEST~~ SUMMERTREE
RECREATION FACILITY, INC. ("Association").

A. All references to the name of the Association as "Pointe West Recreation Facility, Inc.," are hereby deleted in the Amended and Restated Articles of Incorporation and shall hereinafter be changed to "Summertree Recreation Facility, Inc." All other terms and provisions of the Amended and Restated Articles of Incorporation, not specifically amended or altered hereby shall continue in full force and effect.
