As used herein, words underlined are added and words ~~hyphenated~~ through are deleted.

Article 10 of the Articles of Incorporation shall be amended to read as follows:

The original By-Laws ~~are to be made by the Board of Directors.~~
~~The same~~ may thereafter be amended only with the approval of
sixty percent (60%) ~~of all of the directors and not less than~~
seventy-five percent (75%) of the members of the Association.
