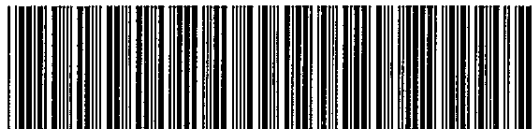





**CERTIFICATE OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
SAND DOLLAR NORTH CONDOMINIUM ASSOCIATION, INC.**

The Articles of Incorporation of Sand Dollar North Condominium Association, Inc. were filed with the Florida Secretary of State on August 18, 1983 and amendments on June 9, 1989, and January 29, 1996. The same Articles of Incorporation and amendments were recorded in the Official Records of St. Lucie County, Florida at Official Records Book 408, Page 2495, et. seq, and amendments at OR Book 642, Page 2045 and OR Book 1501, Page 1124. The same Articles of Incorporation are hereby amended as approved by the Board of Directors by vote sufficient for approval at a Board Meeting held on May 26, 2003.

1. Articles I and II are amended to read as follows:

**ARTICLE I
NAME**

The name of the incorporation shall be Dune Walk by the Ocean Condominium Association, Inc. For convenience, the corporation will be referred to in this instrument as the Association.

**ARTICLE II
PURPOSE**

2.1 The purpose for which the Association is organized is to provide an entity pursuant to the Condominium Act, which is Chapter 718, Florida Statutes, 1981, for the operation of Dune Walk by the Ocean Condominium, located upon the lands lying and being on Hutchinson Island, in St. Lucie County, Florida, and more particularly described by Section 3 of that certain Declaration of Condominium for Dune Walk by the Ocean Condominium.

(The balance of Articles I and II remain unchanged)

2. The foregoing amendment to the Articles of Incorporation of Sand Dollar North Condominium Association, Inc. was adopted by the membership by a vote sufficient for approval at a Special Members ' Meeting held on June 6, 2003.

3. The adoption of this amendment appears upon the minutes of said meeting and is unrevoked.

4. All provisions of the Articles of Incorporation of Sand Dollar North Condominium Association, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.

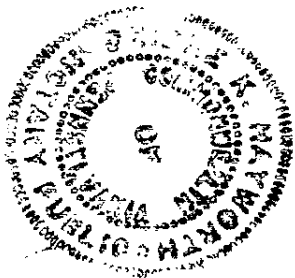

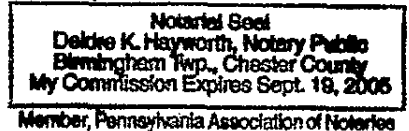
