

The undersigned, being the sole member and all of the directors of HUNTINGTON RIDGE CONDOMINIUM ASSOCIATION, INC., a Florida no profit corporation (the "Corporation"), acting pursuant to the terms of §617.1402 and .0821, Florida Statutes, and by agreement of the undersigned not otherwise proscribed by the Corporation's Articles of Incorporation or By-Laws, hereby take the following written actions in lieu of holding a meeting regarding same:

- 1. <u>Dissolution of Corporation</u>. It is hereby agreed that the Corporation shall be dissolved pursuant to Section 617.1402, <u>Florida Statutes</u>, and in that regard, it is agreed that the Corporation shall file with the Florida Secretary of State its Articles of Dissolution in the form of Exhibit "A" attached hereto.
- 2. Winding Up of Business of the Corporation. The Corporation shall immediately cease the active conduct of its business and shall cause notice thereof to be mailed to each known creditor of, and claimant against, the Corporation, if any. It shall then proceed to collect its assets; convey and dispose of such of its properties as are not to be distributed in kind to its sole member; discharge its liabilities and obligations or make adequate provision for discharge thereof; and do all other acts required to wind up and liquidate its business and affairs, all in accordance with Section 617.1406, Florida Statutes. The Corporation shall then distribute the remainder of its assets, if any, either in cash or in kind, to its sole member, which assets shall be received by the member incident to this plan of complete liquidation and in consideration of the surrender and cancellation of all issued and outstanding membership interest of the Corporation owned by the member.
- 3. <u>Procedural Matters</u>. Each officer of the Corporation is authorized and directed, in the name and on behalf of the Corporation and under its seal or otherwise, to execute and deliver all such documentation necessary to effect such liquidation and dissolution and to take all such further action as such officer, in his, her or its discretion, may consider necessary or appropriate in order to effect the full intent and purpose of these written actions to liquidate the Corporation in accordance with applicable law.
