The undersigned hereby associate themselves for the purpose of forming a corporation not-for-profit under Chapter 718 of the Florida Statutes (the "CONDOMINIUM ACT"), and for clarification, the CONDOMINIUM ACT shall mean the Florida Condominium Act, currently numbered as Chapter 718 of the Florida Statutes, as such Condominium Act may be amended and renumbered from time to time (and specifically includes, without limitation, Sections 718.116, 718.117, and 718.701-718.708, Florida Statutes as they exist as of July 1, 2013, subject to future renumbering and amendments), and certify as follows:
