

Articles of Incorporation

of

CENTRAL PLAZA CONDOMINIUM ASSOCIATION, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida non-for-profit corporation adopts the following amendments to its Articles of Incorporation:

- 1. <u>Name</u>. The name of the corporation is CENTRAL PLAZA CONDOMINIUM ASSOCIATION, INC., a Florida not-for-profit corporation.
- 2. <u>Text of Amendment</u>. Article III of the Articles of Incorporation is amended to conform the voting rights of members to applicable provisions of the Declaration of Condominium of Central Plaza Condominium. The text of the amendment is as follows: (words deleted are lined through with hyphens and words added are underlined):

ARTICLE III MEMBERS

Each condominium unit shall have appurtenant thereto a membership in the corporation, which membership shall be held by the person or entity, or in common by the persons or entities owning such unit, except that no person or entity holding title to a unit as security for performance of an obligation shall acquire the membership appurtenant to such unit by virtue of such title ownership. In no event may any membership be severed from the unit to which it is appurtenant.

Each membership in the corporation shall entitle the holder or holders thereof to exercise that-proportion of the total-voting power of the corporation corresponding to the proportionate undivided interest in the common elements appurtenant to the unit to which such membership corresponds, as established in the declaration, one vote or voting interest in corporate and association matters.

3. <u>Membership Approval</u>. The foregoing amendment to the Articles of Incorporation was adopted at a duly called and held meeting of the members of the corporation on the 17th day of December, 2020. The amendment was proposed by at least one-fourth of the directors and adopted by the affirmative vote of those members exercising not less than a majority of the total voting interest of the corporation. The amendment was adopted by the members and the number of votes cast for the amendment was sufficient for approval.
