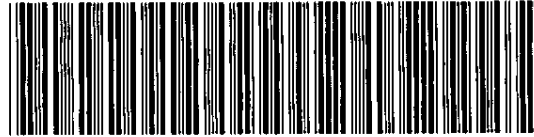

**Articles of Dissolution**

Pursuant to Sections 617.1402 - 1403 of the Florida Statutes, this corporation submits the following articles of dissolution:

1. The name of the corporation is **Friday Road Worship Center, Inc.**; and
2. The effective date of dissolution is August 31<sup>st</sup>, 2014; and
3. The corporation has no members and the dissolution was approved by the board of directors of the corporation on August 19, 2014. The number of votes cast for dissolution was sufficient for approval; and
4. That all liabilities and obligations of the corporation have been paid or discharged or that adequate provision has been made therefore; and
5. That all remaining property and assets of the corporation, to the extent there are any, shall be distributed in accordance with its articles of incorporation to **East Coast Christian Center, Inc.**, another 501(c)(3) church organization; and
6. That there are no actions pending against the corporation in any court or that adequate provision has been made for the satisfaction of any judgment, order or decree which may be entered against it in any pending action.

**WHEREAS**, On August 19, 2014, at a meeting in which adequate notice was provided and at which a quorum was present, the members and directors of **Friday Road Worship Center, Inc.**, a Florida Not-For-Profit corporation, (the "Corporation") met for the purpose of approving the dissolution of the Corporation pursuant to F.S.S. 617, Sections 1402 and 1403 and approved the effective date of the dissolution of the Corporation as of August 31<sup>st</sup>, 2014.

**RESOLVED**: That all liabilities and obligations of the Corporation have been paid or discharged or that adequate provision has been made therefore; and

**FURTHER RESOLVED**: That all remaining property and assets of the Corporation, to the extent there are any, shall be distributed to **East Coast Christian Center, Inc.**, a 501(c)(3) church organization in accordance with the Corporation's articles of incorporation; and

**FURTHER RESOLVED**: That there are no actions pending against the Corporation in any court or that adequate provision has been made for the satisfaction of any judgment, order or decree which may be entered against it in any pending action; and

**FURTHER RESOLVED**: That upon the effective date of the dissolution, the Corporation will have no outstanding business and have no remaining assets or debts. That the dissolution of **Friday Road Worship Center, Inc.** pursuant to F.S.S. 617.1402 and 1403 is formally approved effective August 31<sup>st</sup>, 2014 and the president of the Corporation is authorized to file the appropriate documents with the state of Florida, Secretary of State, Division of Corporations to effectuate the dissolution.
