
ARTICLES OF AMENDMENT

These Articles of Amendment are executed pursuant to Chapter 425, Florida Statutes.

Pursuant to the provisions of Section 425.13, Florida Statutes, and Article VI. Section 5 of the Articles of Incorporation. **SUMTER ELECTRIC COOPERATIVE, INC.**, a Florida Rural Electric Cooperative with its principal office at 330 South U.S. Highway 301, Sumterville, Sumter County, Florida, hereby amends the Articles of Incorporation originally filed in the office of the Secretary of State on January 15, 1938, and amended from to time thereafter, on this day of April, 2019, as follows:

Article VI Section 5, which presently reads

Section 5. The voting power and property rights and interests of each member shall be equal, and each member shall be entitled to one vote and no more upon each matter submitted to a vote at a meeting of the members, which vote shall be in person or by proxy as provided in the Bylaws of the Association. Except as otherwise provided by law, these Articles of Incorporation or the Bylaws of the Association, at all meetings of the members at which a quorum is present, all questions shall be decided by a vote of a majority of the members present in person or, represented by proxy. The election of Trustees shall be as provided by the Bylaws.

Is deleted and in its place shall be inserted:

Section 5. The voting power and property rights and interests of each member shall be equal, and each member shall be entitled to one vote and no more upon each matter submitted to a vote at a meeting of the members, which vote shall be in person or by proxy as provided in the Bylaws of the Cooperative. Ballots may be received by mail or electronic transmission if and to the extent authorized by the Bylaws of the Cooperative and not prohibited by law. Except as otherwise provided by law, these Articles of Incorporation or the Bylaws of the Cooperative, at all meetings of the members at which a quorum is present, all questions shall be decided by a vote of a majority of the members present in person, represented by proxy and, where authorized by the Bylaws

of the Cooperative and not prohibited by law, having delivered ballots by mail or electronic transmission. The election of Trustees shall be as provided by the Bylaws.

The above amendment was duly adopted by the members of Sumter Electric Cooperative. Inc. on the 23rd day of March. 2019 at the annual meeting of members held in accordance with Section 425.09(2). Florida Statutes, and as provided in the Bylaws of Sumter Electric Cooperative, Inc.


