Re: INTERIOR SEALD-SWEET SHIPPERS, INC.

Ladies and Gentlemen:

I represent Interior Seald-Sweet Shippers, Inc., a cooperative association incorporated under Chapter 618, Florida Statutes. Enclosed is a certified copy of Articles of Incorporation of Interior Seald-Sweet Shippers, Inc. filed on December 2, 1970, and bearing the Great Seal of the State of Florida.

The response to a recent telephone inquiry to the Corporations Division concerning the status of Interior Seald-Sweet Shippers, Inc. was that there is no record at the Division of this entity either existing or having existed under authority of Florida law. The enclosed certified copy of Articles of Incorporation clearly shows that Interior Seald-Sweet Shippers, Inc. was in fact incorporated under authority of the Florida statutes.

The records of Interior Seald-Sweet Shippers, Inc. contain no evidence of voluntary or judicial dissolution of the entity, nor do they contain any evidence of notice of administrative dissolution. I am personally familiar with the corporate activities of Interior Seald-Sweet Shippers, Inc. from 1974 to the present, and I can certify no action was taken to voluntarily or judicially dissolve the corporation at any time during this period.

The most likely scenario for the absence of any current record of corporate existence of Interior Seald-Sweet Shippers, Inc. at the Division appears to be administrative dissolution under Section 607.1421. If this premise can be substantiated by a further search of your records, or accepted in the absence of better evidence, the procedures to reinstate Interior Seald-Sweet Shippers, Inc. to active status appear to be available under authority of Section 607.1422, Florida Statutes.

Although Interior Seald-Sweet Shippers, Inc. was incorporated under Chapter 618 rather than Chapter 607, Chapter 618 provides for application of general corporation laws to cooperative association in the following provisions of Section 618.24:

“618.24 Application of general corporation laws.—

“The provisions of the laws of this state with respect to corporations for profit and all powers and rights thereunder shall apply to associations organized under this chapter,

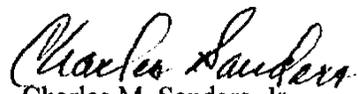

except where such provisions are in conflict with or inconsistent with the express provisions of this chapter.”

Interior Seald-Sweet Shippers, Inc. hereby applies for reinstatement of its charter. Enclosed is the designation of and acceptance by Mr. C. Michael Moody as registered agent, together with the check of Seald-Sweet Growers, Inc., affiliate of Interior Seald-Sweet Shippers, Inc. in the amount of \$420.00, (\$385.00 for reinstatement, \$35.00 for resident agent), as prescribed in the Division's Schedule of Fees.

We appreciate your prompt attention and response to this matter. Please return the enclosed copy of the Articles of Incorporation to me, as this is the only certified copy known to exist.
