

## AMENDMENT TO THE ARTICLES OF INCORPORATION OF FLORIDA SUGAR MARKETING & TERMINAL ASSN.. INC.



Pursuant to Section 618.05, Florida Statutes, the President and Secretary of FLORIDA SUGAR MARKETING & TERMINAL ASSN., INC., a Florida corporation (the "Association"), an Agricultural Cooperative Marketing Association organized and existing under the provisions of Chapter 618, Florida Statues, certify as follows:

- 1. This Amendment to the Articles of Incorporation was adopted by the unanimous vote of all of the members of the Association at the annual meeting of the members held on January 11, 2005. This Amendment was also approved by the unanimous vote of the Board of Directors of the Association at a meeting also held on January 11, 2005.
- 2. Article VI of the Association's Amended and Restated Articles of Incorporation shall be amended by inserting the following new Section 7.

SECTION 7. ALTERNATE DIRECTORS. Each member that is entitled to nominate and have elected one or more directors pursuant to Section 2 of this Article shall also be entitled to nominate and have elected one alternate director. An alternate director may attend each meeting of the Board of Directors, but shall not be counted for purposes of determining a quorum at the meeting and shall not be entitled to vote at the meeting unless a director nominated by the member that nominated the alternate director is not in attendance at the meeting. The term of any alternate director shall coincide with the term of the director or directors for which the alternate director serves as an alternate. Any vacancy in an alternate director position must be filled by the Board of Directors. Any new alternate director shall be nominated by the same member that originally nominated the alternate director whose position was vacated or is vacant, and shall serve for the unexpired

term. The new alternate director shall be elected by a majority of the Board of Directors. Any member shall have the right to remove an alternate director nominated by such member by providing written notice to the Association.
