#### THE RESTATED CHARTER

OF

#### THE EQUITABLE LIFE ASSURANCE SOCIETY OF THE UNITED STATES

Under Section 1206 of the New York Insurance Law and Section 805 of the New York Business Corporation Law

The undersigned, being the Chairman of the Board, President and Chief Executive Officer and the Senior Vice President, Secretary and Associate General Counsel, respectively, of The Equitable Life Assurance Society of the United States (the "Corporation"), a New York corporation, hereby certify as follows:

- 1. The name of the Corporation is The Equitable Life Assurance Society of the United States.
- 2. The Charter of the Corporation was filed in the office of the Superintendent of Insurance of the State of New York on May 10, 1859.
- 3. The Charter of the Corporation, as amended and restated prior to the date hereof (the "Charter"), is hereby further amended, as authorized by Section 1206 of the New York Insurance Law and Section 805 of the New York Business Corporation Law, to (i) change the name of the Corporation to AXA Equitable Life Insurance Company and (ii) to grant the Board of Directors the power to authorize the use in a foreign country where the Corporation does or proposes to do business of a specified translation of its name in any language commonly used in such country.
  - (a) Article I of the Charter, which sets forth the name of the Corporation, is hereby amended to read in its entirety as follows:

#### ARTICLE I

The name of the corporation shall be AXA Equitable Life Insurance Company.

(b) A new Article IX is hereby added to the Charter to read in its entirety as follows:

#### ARTICLE IX

The Board of Directors shall have the power and authority to authorize the use in a foreign country where the corporation does or proposes to do business of a specified translation of its name in any language commonly used in such country.

4. The foregoing amendments were duly authorized, adopted and approved, pursuant to Sections 803(a) and 615(a) of the New York Business Corporation Law, at a meeting duly called and held on September 19, 2002 by vote of the Board of Directors of the Corporation, followed by written consent, setting forth the action so taken, signed by the holder of all outstanding shares of the Corporation.
