In compliance with the requirements of Section 1915 of the Business Corporation Law of 1988 (15 Pa. C. S. §1915) and Section 21204 of the GAA Amendments Act of 1990 (15 P.S. §21204), 21st Century Premier Insurance Company desires to restate in their entirety its original Articles of Incorporation and all amendments thereto, and, thereby, cause these Amended and Restated Articles of incorporation to supersede such original Articles of Incorporation and all amendments thereto.

#### ARTICLE I.

The name of this corporation shall be 21th Century Premier Insurance Company.

#### ARTICLE IL

- (a) The address of the corporation's registered office in the Commonwealth of Pennsylvania is c/o Corporation Service Company, Dauphin County.
- (b) The curporation's principal place of business shall be located at 21st Century Plaza, 3 Beaver Valley Road, Wilmington, DB 19803.

#### ARTICLE DL
