#### ARTICLES OF AMENDMENT



- (1) The name of the corporation is Liberty Mutual Fire Insurance Company.
  - (2) The text of the amendment as adopted is as follows:

### AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

LIBERTY MUTUAL FIRE INSURANCE COMPANY

WHEREAS Liberty Mutual Fire Insurance Company was incorporated on October 31, 1908 under the laws of the Commonwealth of Massachusetts, in compliance with the requirements of Section 576 of the Acts of 1907 of the Commonwealth of Massachusetts, and

WHEREAS Liberty Mutual Fire Insurance Company desires to become a domestic insurer under the laws of the State of Wisconsin by complying with the provisions of Section 611.223 of the Wisconsin Statutes and intends that, as of the date when the Commissioner of Insurance of the State of Wisconsin issues to Liberty Mutual Fire Insurance Company a certificate of incorporation as a Wisconsin domestic insurer (the "Transfer of Domicile"), Liberty Mutual Fire Insurance Company shall be bound by all the terms and provisions of the Wisconsin Statutes applicable to domestic stock insurance corporations incorporated thereunder,

NOW, THEREFORE, when the Transfer of Domicile has been effected, the articles of incorporation of Liberty Mutual Fire Insurance Company shall be as follows:

#### ARTICLES OF INCORPORATION

OF

LIBERTY MUTUAL FIRE INSURANCE COMPANY

These restated articles of incorporation of Liberty Mutual Fire Insurance Company (the "corporation") supersede and take the place of heretofore existing articles of organization or articles of incorporation previously adopted and all amendments to the original and any restated articles of organization or articles of incorporation. The corporation is organized under Chapter 611 of the Wisconsin Statutes.

#### ARTICLE I

#### BUSINESS TO BE UNDERTAKEN

The corporation is authorized to transact the business of insuring persons and organizations against any and all of the hazards as may be authorized or permitted for stock insurance corporations under

the laws of the State of Wisconsin as they are now or as they may hereafter be enacted or amended, and to reinsure those same hazards and at the option of the corporation to issue participating policies of insurance in respect to any of such hazards; and to have, exercise and enjoy, without limitation, all of the powers, privileges and rights conferred upon or permitted to stock insurance corporations which are necessary or convenient to effect any or all of the purposes for which such corporations may now or hereafter be organized under the laws of the State of Wisconsin.

#### ARTICLE II

#### NAME AND LOCATION

The name of the corporation shall be Liberty Mutual Fire Insurance Company, and its location, home office and principal office shall be established in the manner set forth in the corporation's bylaws.

#### ARTICLE III

#### PERIOD OF EXISTENCE

The period of existence of the corporation shall be perpetual.

#### ARTICLE IV

#### CAPITAL STOCK

The aggregate number of shares of capital stock which the corporation shall have authority to issue shall be one hundred thousand (100,000) shares, and shall consist of one class only, designated as common shares, each with a par value of one hundred dollars (\$100.00).

#### ARTICLE V

#### REGISTERED OFFICE

The address of the initial registered office is 2000 Westwood Drive, Wausau, Wisconsin 54401.

#### ARTICLE VI

#### REGISTERED AGENT

The name of the initial registered agent at the address of the registered office is J. Stanley Hoffert.

#### ARTICLE VII

#### OFFICERS AND DIRECTORS

- 1. The principal officers of the corporation shall be as designated in the corporation's bylaws.
- The number of Directors of the corporation constituting the Board of Directors of the corporation shall be fixed in accordance with the corporation's bylaws and may be increased or decreased from time to time in the manner provided in such bylaws.

#### ARTICLE VIII

#### FISCAL YEAR

The fiscal year of the corporation shall terminate on December 31 of each year.

#### ARTICLE IX

#### RESTRICTIONS AND TRANSFER OF STOCK

The transfer of shares of stock of the corporation may be restricted, provided that any such restriction shall be stated upon the certificate representing the shares so restricted.

#### ARTICLE X

#### PRE-EMPTIVE RIGHTS

No shareholder shall, because of his ownership of shares, have a pre-emptive or other right to purchase, subscribe for, or take any part of any shares or any part of the notes, debentures, bonds, or other securities convertible into or carrying options or warrants to purchase shares of the corporation issued, optioned or sold by it after its incorporation.

#### ARTICLE XI

#### **AMENDMENTS**

These Articles may be amended in the manner authorized by law at the time of amendment.

- (3) The amendment does not provide for an exchange, reclassification or cancellation of issued shares.
  - (4) The date on which the amendment was adopted is December 22, 2005.
- (5) The amendment requires shareholder approval and was adopted in accordance with Section 180.1003, Wisconsin Statutes.
