



Series Preferred Stock (Cumulative) for cancellation pursuant to
the Annual Retirement Fund provision and has redeemed 11,730

PERSONAL PROPERTY.

The authorized number of shares of the Company is 12,182,000 shares, classified as follows:

182,000 shares of Preferred Stock (Cumulative) with the par value of \$100.00 per share, aggregating in par value \$18,200,000.

12,000,000 shares of Common Stock with the par value of \$6.25 per share, aggregating in par value \$75,000,000.

"The proper officers of the Company are authorized and directed to execute and file with the Secretary of State of the State of Ohio a Certificate of such amendment."

3. The authorized number of shares of Freferred Stock (Cumulative) of said corporation accordingly is reduced by 12,000.
